### **Cancellation Policy**

A \$15 transfer fee will be assessed on any CISR or one-day seminar transfer made within 2 weeks of the program. Transfers may only be made to another MAIA course. Student must indicate a transfer course within two weeks of cancellation or appropriate percentage of tuition will be refunded.
