The CIC designation stands for Certified Insurance Counselor. It signifies a high level of professional education and a commitment to a course of continuing education. The CIC designation is earned by attending five, threeday institutes and passing an exam on the material at the end of each course.

## Agenda

Registration is from 7:30-8 a.m. on Wednesday and the class begins at 8 a.m. Lunch is on your own each day and is from 12-1 p.m. The class ends around 5 p.m. each day, with the test scheduled from 2-4 p.m. on Friday. Exact agenda may vary by institute. Visit our website for detailed agendas.

#### \*James K. Ruble Seminar (Open to dues paying National Alliance members only.)

Beginning in 2012, the JKR Graduate Seminar is a two-day seminar. The JKR Graduate Seminar is a state-sponsored Ruble Seminar (formerly Advanced Coverage), for meeting the CIC continuing education commitment.

# **Cancellation Policy**

You will not receive a refund or transfer credit if you do not notify us before the start of the event. All cancels and transfers must be received in writing. Refunds: a 90 percent refund applies if cancelling more than two weeks prior to start of event; 75 percent refund if cancelling fewer than two weeks before the event. Transfers: A \$30 transfer fee will be assessed on any CIC transfer made within 2 weeks of the program. A \$15 transfer fee will be assessed on any CISR or one-day seminar transfer made within 2 weeks of the program. Transfers may only be made to another MAIA course. Student must indicate a transfer course within two weeks of cancellation or appropriate percentage of tuition will be refunded.
