WHAT IS THE CISR DESIGNATION?

The CISR designation stands for Certified Insurance Service Representative. It is designed to serve the practical needs of customer service representatives, newly licensed producers, company personnel, and those who wish to refresh their product knowledge. Participants pursuing the designation must attend and pass five one-day courses over a three-year period.

Each institute will be filed for continuing education credit in all states. Exact CE hours and type may vary by institute.

Effective January 1, 2022, The National Alliance has changed the guidelines for CISR in-person courses. CISR in-person courses will no longer offer a paper exam option. CISR exams must now be taken online through the PROfile page. For participants who want to take the exam the day of the course, MAIA will proctor the exam immediately following the course, but participants must provide their own equipment to take the exam. The exam can also be taken online until Thursday at 11:59 p.m. the week following the class, but will require a disinterested third party to proctor the exam. Effective July 1, 2022, all CISR in-person, hybrid, and webinar courses will have the same exam window for taking the final exam. The exam window will begin immediately after the course concludes through the following Thursday at 11:59 pm Central Time Zone. The exam windows during the holidays throughout the year will be determined in advance and adjusted accordingly.
