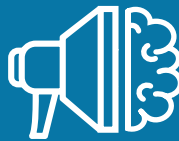

**Cancellation, Refunds & Transfers Policy:** You will not receive a refund or transfer credit if you do not notify us before the start of the webinar. All cancels and transfers must be received in writing. Refunds: a refund will be provided if canceling more than two weeks prior to start of webinar, less a \$5 handling fee; if canceling fewer than two weeks before the webinar, a \$10 handling fee will apply. Transfers: a \$5 transfer fee will be assessed on any transfer made within 2 weeks of the webinar. Transfers may only be made to another MAIA course. Student must indicate a transfer course within two weeks of cancellation or appropriate remainder of tuition will be refunded.
